Effect of frequent WBC treatments on the back pain therapy in elderly men

Effect of frequent WBC treatments on the back pain therapy in elderly men

SUMMARY

Cryotherapy is the application of a stimulus of a cryotherapeutic temperature below -100° C in a period of 1 to 3 minutes in order to stimulate and use physiological reactions of human body to cold. It can be applied to specific body parts or to a whole body.

Whole body cryotherapy is a treatment method applied in treatment of motor organ issues, nervous system diseases, psychiatry, dermatology and laryngology.

The research group consisted of 80 male in the age range of 65 – 77 suffering from chronic, lasting more than 3 months lower back pain. The subjects qualified to the research were divided into two groups. Group A consisted of 40 patients who participated in WBC twice a week. Group B also contained 40 patients who participated in WBC whole week. Examinations were conducted twice. The first one was conducted before the commencement of the treatment while the second one after the therapy was over.

The results of the research did not show any statistically significant improvement in patients from Group A. However, the results obtained by Group B have proven significant condition improvement and enable the researchers to conclude that WBC is effective in treating patients with lower back pain.

An interest in whole-body cryotherapy is becoming greater with each year. Cryotherapy is the application of a stimulus of a cryotherapeutic temperature below -100 0 C in a period of 1 to 3 minutes in order to stimulate and use physiological reactions of human body to cold ¹. It can be applied to a whole body or to its specific parts.

Systemic cryotherapy is an important treatment method applied in treatment of not only motor organ issues but also nervous system diseases, psychiatry, dermatology and laryngology ². Applied in wellness and sports medicine WBC helps maintaining good health condition of healthy people. Clinical results of cryotherapy include: pain relief ^{3, 4} and reflexive congestion of skin and limbs ⁵ which leads to faster healing of wounds. It has anit-oedematous and anti-inflammatory effect ^{6, 7}, reduces muscle tone ^{8, 9}, increases muscle strength ^{10, 11, 12}, improves mood ¹³, and additionally has a strong influence on physical capacity ^{14, 15} and the ability to intensify the healing process ¹.

The existing knowledge does not explain all the aspects of the effect of low temperatures on human body. Articles presenting the effects of whole-body cryotherapy on the human body are ambiguous and divers. Despite an increasing number of scientific research tackling an issue of the influence of WBC on the human body it needs to be emphasized that their results are very often insufficient and sometimes contradictory ^{1, 16}. Moreover, most of the research is conducted on young subjects.

There are very few research papers in world literature which describe the influence of WBC on elderly people and the results of those treatments applied to specific aliments. Based on a review of the available articles it can be concluded that WBC is a safe procedure ¹⁷. However, researchers should carefully select patients subject to WBC (especially elderly people) as well as abide the limitations and conduct WBC according to its procedures. Assuming that the WBC treatment in an examined group of patients requires outmost caution

in regard to their age the authors tried to determine a dosage of a WBC stimulus which would be the most effective and safe for the examined group of patients.

Unfortunately, there is a big difference in methodology applied by the users of Cryotherapeutic chambers which can be reflected in the number of treatments in series, frequency of treatments, duration of a single treatment and applied range of temperatures. Hence, it is necessary to conduct research which would describe a detailed influence of WBC procedures on the human body. Therefore, the researchers tried to determine the frequency of WBC treatments effective in therapy. It was assumed that WBC procedures will have a positive effect in lower back pain treatment.

MATERIALS AND METHODS

The research group consisted of 80 male in the age range of 65 - 77 (mean 70,1) suffering from chronic, lasting more than 3 months lower back pain. The subjects were chosen on the basis of interviews which enabled researchers to determine the characteristics of the pain and its duration. The cause of pain was established on the basis of an objective tests results of X-ray and MRI.

The patients excluded from the research suffered from an acute pain ailments, damage to nerve roots (Laseqeu's sign of sensory disturbance, paresis) or different diseases, such as: irregular hypertension, osteoporosis or circulatory failure. There were also patients who were unable to participate in the whole-body cryotherapy due to health conditions. The current knowledge enables us to determine the following limitations: claustrophobia, cold intolerance, Raynaud's disease, hypothyroidism, acute respiratory disease, cancer, cardiovascular diseases (unstable angina pectoris, aortic valve stenosis or venous stenosis of the left mouth, circulatory failure, dangerous arrhythmias) gangrenous skin lesions, sympathetic neuropathies, local circulatory disorders, emaciation and hypothermia ^{1, 18}.

The subjects qualified to the research were randomly divided into two separate groups.

Group A consisted of 40 patients who participated in WBC twice a week on Tuesdays and Fridays. Group B also contained 40 patients who participated in WBC whole week from Monday to Friday. Examinations were conducted twice. The first examination was conducted before the commencement of the therapy (Examination 1) while the second (Examination 2) was a day after the three week course. The whole-body cryotherapy treatments were conducted in a Cryogenic chamber type CR 2002 which consisted of a vestibule and main chamber (fig. 1). with treatment lasting 3 minutes. When a subject entered the vestibule, they spent there approximately 30 seconds at a temperature of -60° C to adopt to the cold. Next, the subject moved to the main chamber. At a temperature -120° C they spent another 3 minutes, during which they were subject to the proper whole-body cryotherapy. After the procedure, the subjects left the chamber and went to a gym. The subjects performed the same therapeutic exercises 5 days a week, 45 minutes a day for a period of 3 weeks, with all exercises being supervised by a qualified physiotherapist. During the research none of the patients used other physical therapy or applied pharmacological treatment.

All measurements (mobility measurements and EMG recordings) were taken by the same person and at the same time of day. Also, the overall testing conditions (humidity, lighting and temperature) were kept constant for all measurements.

The research evaluated the lumbar spine mobility. The measurements of: active flexion and extension, rotation to the right and left, and lateral flexion to the right and left were taken. Spine mobility was measured by the use of devices applied in a DBC method devices are used in functional diagnostics and therapy. Their construction enables the performance of a movement of a selected part of the spine. Each device equipped in a build-in supporter enabled complete lower limb stabilization and facilitated precise performance of a movement. An angle scale embedded in each device made it possible to measure the mobility of the spine. In order to maintain constant measurement conditions, the settings of the devices were recorded on a magnetic card owned by each subject (height of a seat, feet supporting platform, etc.)¹⁹.

Measurement of active flexion and extension of the lumbo-thoracic spine¹⁹:

The measurement of a movement in the sagittal plane was conducted by the use of the device with the symbol LTE (fig. 2). During that measurements, the subject remained in a sitting position and their feet were placed on a platform. In order to eliminate compensatory movements, researchers adjusted the height of the platform for each subject. They used the mechanism to stabilize hip joint inflexion. Thighs and pelvis were supported by cushions preventing those body parts from rotating. The range of movement was measured by the

measurement system set at the height of the spine at the scapula. Upon a signal, the subject performed maximum flexion until reaching the first sensation of pain, then maximum extension to the same extent. Angle values were taken from a scale attached to the device.

Measurement of an active rotation of the lumbo – thoracic spine ¹⁹:

The measurement of a movement in the transverse plane was conducted by the use of the device with the symbol LTR (fig. 3). During that measurements, the subject remained in a sitting position. The angle between the thighs and trunk was 90° . This position was stabilized by the mechanism. The shoulders of the subject were stabilized by pads which prevented the subject from moving the upper part of the thoracic spine. Upon a signal the subject performed a maximum rotation to the right and then to the left until the first sensation of pain. Angle values were taken from a scale attached to the device.

Measurement of an active side bend of the lumbo-thoracic spine ¹⁹:

The measurement of movement in the frontal plane was conducted by the use of the device with the symbol LTL (fig. 4). During that measurements, the subject remained in a sitting position. The angle between the trunk, thighs and lower leg was 90^{0} and the feet rested on a platform. The feet rested on the platform. The seat was adjusted to each subject, so the rotation axis for all was within the area of the L2 vertebra. The subject was stabilized in that position by a suitable mechanism, an applicator at the height of shoulders. Upon a signal the

subject performed a maximum rotation to the right and then to the left until the first sensation of pain. Angle values were taken from a scale attached to the device.

EMG measurement of erector spinae in the lumbar part of the spine performed at rest and in flexion. The area to be examined was shaved and cleaned with an abrasive paste and alcohol in order to decrease skin resistance. During the placement of electrodes, the patient's body was slightly leaned forward which facilitated optimum placement of electrodes on the skin for the examination. Electrodes were places symmetrically on both sides of the lumbar spine. The first set of the electrodes was attached at the level of L4 and L5 vertebra, while the second was placed at a greater distance from the spine at the level of L5 and S1 (fig. 5). In order to obtain a comparable EMG signal, researchers used the same conditions for both sets of electrodes (the same resistance between electrodes and signal amplification, and constant distance between electrodes).

Static EMG examined the lumbar erector spinae muscles separately on the right and on the left side. The research was conducted in a free standing position and at maximum flexion and maximum extension. The researchers used a questionnaire which helped them take into account subjective parameters such as: a pain scale by the use of VAS and functional limitations determined by ADL (Activities of Daily Living). Since we are aware about the influence of fatigue on EMG time and domain analysis parameters, we controlled the measurements procedures to avoid an occurrence the fatigue. The static EMG recordings were taken during non-fatigue 5 s periods, divided by 5 minute breaks, that did not cause any fatigue in tested subjects. All EMG recordings were conducted when the subject felt relaxed without any prior experienced physical exercises. The EMG recordings were performed using the DBC surface EMG hardware and software. The stable static 5 s recordings were collected for each condition (standing, flexion and extension) after the required subject's position was correctly set. The DBC EMG software performed automatic calculation of the EMG amplitude, as the RMS (Root Mean Square) from these 5 s periods. The estimation of EMG amplitude (RMS) is appropriate parameter to reveal any neurophysiologic changes related to muscle tone alterations in the context of diagnosis and monitoring of therapy effectiveness. Researcher performing the EMG recordings controlled strictly the stability of the testing conditions, ex. when the EMG recording was performed during the trial with inaccurate body position or with body movement, that trial was discarded and performed once again. Taking into account the literature data with EMG amplitude analysis using RMS parameter, these 5 s periods are enough time-frames to obtain reliable estimate of the EMG amplitude. In many studies authors use 1 s periods and it gives reliable EMG results.

The evaluation of patient response was based on the evaluation of actual pain measured at the beginning and end of the research. Pain was evaluated on the basis of VAS scale (Visual Analogue Scale) from 0 to 100 mm. Patient's task was to evaluate the intensity of the pain regardless of the level of physical fitness. The patient had to put an "x" on the scale where the left extreme meant "no pain" while the right "the strongest pain". At the beginning and end of research, researchers evaluated patients' functional limitations (ADL -Acivities of Daily Living). To accomplish this, they used a scale from 0 to 3 points: 0 stood for "I don't have any problems with that activity" while 3 meant "I can't do it". A subject selected the number which corresponded to their ability to perform each activity listed on the questionnaire.

Statistical analysis was performed by the use of Statistica 9 PL software. Both Shapiro-Wilk and Levene's tests were applied to check normal distribution and homogeneity of variance. Since the obtained results revealed abnormal distribution the Mann-Whitney U test was used to compare the results obtained for both groups. The Wilcoxon signed-rank test evaluated the efficacy results of the therapy for each group. Statistical significance observed was p < 0.05.

RESULTS

Table 1, 2 and 3 present statistical analysis of the results obtained in the research. Values presented in Table 1 taken for both groups before the beginning of a treatment show no significant differences between the mean values of the examined active parameters of the lumbar spine, values of active potentials of erector spinae in the lumbar part of the spine and subjective pain parameters. This suggests that the function of the spine, subjective feeling of pain and the level of functional difficulties were at the same level.

The results obtained in the second examination after the cycle of therapeutic treatment are presented in Table 2. The analysis of these parameters reveals statistically significant differences between the examined groups in all the parameters but the level of functional difficulty. The patients who exercised and participated in whole-body cryotherapy five times a week showed significantly lower values of active potentials of erector spinae muscles in the lumbar part of the spine and a significant increase in the range of the lumbar spine mobility. The level of pain was also significantly decreased. However, the researchers did not observe any changes at the level of functional difficulty caused by pain.

Table 3 contains the results of the comparative analysis of therapy efficacy for both groups. The analysis of the results of the examinations conducted at the beginning and at the end of the therapy did not reveal any significant differences in Group A. However, statistically significant differences observed in Group B enable the researchers to conclude that only systematic WBC is effective in treating patients with lower back pain.

DISCUSSION

This research aimed to determine the frequency of WBC treatments, which along with exercise, have positive influence on the improvement of the functional condition of elderly men suffering from lower back pain. The simple measurement methods applied in the study enabled the determination of lumbar spine activity and patients' sensations. The methods can easily be used in any therapeutic facility.

Approximately fifty percent of adults suffer from lower back pain²⁰. It is a long-lasting ailment causing significant movement limitation, including that related to performing sports. It is especially significant in the case of elderly men. On the one hand, involutionary processes occurring with age deteriorate the functional capabilities of the human body and lead to an increase in the percentage of people with limitation of movement. On the other hand, the limitations caused by lumbar spine ailments limit the abilities of people suffering from lower back pain. The limitations of physical activity which accompany these disorders, especially in old age, may be related to many health issues associated with motor organs and other important human systems. Impaired function of the cardiovascular and respiratory systems and those related to changes in motor organs ²¹ have a negative influence on the impairment on many activities necessary to independent functioning in everyday life²². They also lead to a decrease in physical performance ²¹. Long-lasting pain may also lead to depression²³. Pain related to this problem²³ causes significant limitations to the movement possibilities of patients. Many patients with chronic lumbar pain suffer from so-called deconditioning and have a tendency to avoid movement. Evading movement is caused by the fear of an increase in pain. The decrease in daily physical activity related to age and chronic lumbar pain leads to an impairment of physical abilities, decrease in the range of movement, loss of muscle strength and deterioration of motor coordination^{24, 25}.

Thus, researchers keep searching for new, effective measures which will decrease existing ailments and limit their recurrence. They also hope to increase the physical activity of people. Physiotherapy programs not only decrease lower back pain, but are also a form of physical activity. The authors of this research hope that the therapeutic effect of the performed exercises will also encourage the patients to stay physically active.

One of the barriers which has existed for many years and is a named form of limitation in the improvement process of elderly people is the fear of pain associated with motor organs ²⁵²⁶. Studies conducted for many years revealed the efficiency of physical exercise improving patients suffering from subacute and chronic pain ^{27, 28, 29}. It is commonly known that physical exercise brings excellent results in pain treatment related to motor organs ²⁹. It enables an increase in: the range of joint movement, muscle strength and physical fitness. Regular physical effort extends the period of independence and improves the lifestyles of elderly people ^{26, 30}.

Due to the application of physical therapy, especially those with analgesic, antiinflammatory and relaxing properties, it is possible to intensify kinesitherapy. WBC is a treatment which, thanks to its analgesic and anti-inflammatory properties ^{6, 7}, can be classified as a treatment supporting lumbar pain therapy.

The analgesic and anti-inflammatory effects of WBC have been described in many research papers. Lange et al.⁶ and Algafly et al.⁷ have proven the anti-inflammatory and analgesic activity of these treatments. The anti-inflammatory effect of WBC may result from the influence of low temperatures on the production of inflammatory mediators, as well as pro-oxidant – antioxidant balance. It is important in the treatment of nociceptive pain which is observed in spinal pain syndrome ^{31, 32, 33}.

The efficacy of WBC applied in the treatment of a range of diseases has been presented in many papers. The examples presented herein confirm the results obtained by those authors for Group B. Hirvemen et al.³⁴ and Metzger et al. used cryotherapy treatment on patients with rheumatoid diseases and observed a significant decrease of pain in those patients. Offenbacha at al.³⁶ and Bettoni et al.³⁷ have established an analgesic influence of WBC on patients suffering from fibromyalgia.

The improvement of spine mobility observed by the authors may be related to a decrease in pain, the values of active potentials of erector spinae muscles in the lumbar part of the spine or the positive influence of WBC treatments on inflammation reduction. These factors enabled the patients from Group B (5 treatments) to intensify the process of improvement through the increase of work load during exercises and improvement of their range of movement, resulting in better final results. A study performed by Stanek et al.¹⁸ on AS patients treated with whole-body cryotherapy showed improved spinal movement and muscle relaxation. Moreover, results obtained by Rymaszewska et al.¹³ proved the positive influence of WBC in treatment of patients suffering from depression. Excessive and long-lasting pain observed in patients with lumbar spine ailments ³⁸ may lead to depression ²³. So, the antidepressant properties described by Rymaszewska and an increase in the level of ß-endorphin after WBC reported by Zagrobelny ¹ may potentially improve a patients' willingness to perform physical exercises and to have an influence on better treatment results.

The current research conducted by Bettoni et al.³⁷ uses a standardized questionnaire to confirm the improvement in quality of life of patients with fibromyalgia using WBC as a treatment. In this research the authors did not observe any improvement in the ADL parameter. This may have been caused by the short treatment period. Spine ailments are chronic. All abnormalities caused by long-lasting ailments become permanent for the time of the disease and may be difficult to alter in a three week therapy period.

The effectiveness of WBC therapy has been described many times. Those treatments have also proven effective in the treatment of lumbar pain in elderly people ^{38, 39}. It is

commonly known that a stimulus of extremely low temperature has a strong impact on the human body. Even a single treatment may disturb some functions of the human organism. Evaluation of healthy young people conducted by Giemza et al. after a single WBC treatment ⁴⁰ showed the imbalance. Lubkowska ⁴¹ in her research on youth observed an increase in the systolic blood pressure right after the first day of WBC treatment. In her next paper ⁴², she proved an increase of ISO-P-8 - marker of oxidative stress after the first WBC session. While Smolander ⁴³ made observations about the decrease of FEV₁ in young males which had been subject to WBC treatments. Bearing in mind that WBC procedures may be used to treat elderly patients, one should consider the analysis of these results and pose the question whether a decrease of the number of treatments from five to two per week will bring the same results and be equally effective ³⁹.

An analysis of the results obtained from Group B, which consisted of patients who participated in the WBC treatment regularly five times a week, showed a significant improvement in almost all analyzed parameters. Such improvements were not observed in the group of patients who attended WBC sessions only twice per week. It was probably caused by the lack of positive body response to cryogenic temperatures. Anti-inflammatory properties of WBC treatments result from an influence of extreme cold on concentration of inflammatory markers and pro-antioxidant balance. These properties decrease a nociceptive pain occurring in degenerative joint diseases and spinal pain syndromes ^{30, 31, 32}. WBC leads to muscle relaxation and increases pain tolerance which enable to increase range of movements ¹⁸.

Analgesic and anti-inflammatory effect, decrease in an excessive muscle tension and increase in a range of movements enabled subjects from Group B to increase a workload and intensity of the performed exercises. On the other hand, willingness to perform physical activities observed in that group might have been caused by an increase at the level of β -endorphins after the WBC treatments (Zagrobelny). All that could have led to obtaining better

effects of the back pain treatment therapy observed in the results of Group B in comparison to those of Group A. An important part may have been played by the antidepressant properties of WBC described by Rymaszewska et al.¹³ since chronic back pain may cause depressive states. The lack of improvement in patients from Group A may result from the fact that they failed to obtain a desirable result of WBC treatment due to its rare use. Hence, positive effects of this treatment did not overlap and did not bring positive effects at the end of the therapy.

Equally significant is a fact that only repetitive WBC treatments activate adaptive mechanisms which increase antioxidant capacity of organism and decreases oxidative stress. Lubkowska's ⁴³ research have shown that a single WBC treatment causes changes in total and antioxidant plasma capacity.

Intensification of free-radical reactions caused by extreme cold leads to short and temporary pro-antioxidant imbalance. However, repetitiveness of the treatments activated adaptive mechanisms increasing antioxidant capacity of organism and readiness of protective mechanisms against oxidative damage ⁴⁴.

The presented results prove that only the regular application of WBC treatments is effective. It is common knowledge in physiotherapy that only treatments which are performed systematically within a certain period of time bring intended results. Due to that, the treatments performed one after another overlap and give positive effects. When the period between treatments is too long, positive results disappear and the procedures which occur next do not have a positive influence on a patient because they do not add up. The results presented in this research support this notion.

In recent years there have been a number of studies dealing with the impact of WBC on the human body. Despite the large amount of research, the results are still ambiguous and incomplete ³⁹. However, unequivocal criteria which would enable the classification of patients able to utilize WBC procedures have not been created yet. Also, there are no criteria which

would determine the application of WBC treatments to patients of different ages. Thus, cryotherapy treatments applied to elderly people should be selected very cautiously and adjusted to their individual needs depending on the anticipated result. Staff performing the procedure should be well qualified and follow the procedures of such treatments.

In summary, it can be stated that systematic whole-body cryotherapy treatments are effective in treating people suffering from lower back pain. It is also safe for elderly people. Existing textbooks on WBC treat the age of 65 as the borderline for relative contradiction to using whole-body cryotherapy. However, this was written in the 1980s when whole-body cryotherapy was introduced to physiotherapy as a form of treatment. Its creators probably had in mind the safety of patients and the lack of research on that matter which could not influence their opinion.

The authors of this research are aware that the study does not contain information of the durability of positive effects of WBC treatments. But this matter is still under research and the obtained results will be presented after its completion.
